**Item 1. Minutes of 2013/14 AGM**

Moved Richard Mellon Seconded Les Scott that the 2013/14 AGM Minutes be accepted. CARRIED

**Item 3. Presidents Report.**

Richard Mellon read his 2014/15 Presidents Report, which would be available for members to read on the AFA web. Richard provided an overview of achievements in 2014/15 including membership (full members 533; total including Associates 746 and 774 registered dogs); Number of clubs 44; number of competitions 55, Stewards 105; Timekeepers 42 and Judges 25. He thanked the outgoing Committee for its work throughout the year.

#### **Item 4 Financial Statements and Auditors Report.**

The President introduced the 2014/15 AFA Financial Statements and the accompanying Auditors Report and invited any comments or questions. No questions or comments.

#### **Item 5. Announcement of results of postal Rules ballots**

The President asked the NSW Returning Officer to read the results of the postal ballot for the 2 Rule changes circulated to all members. The Returning Officer advised the meeting that that both Motions submitted to members had received the required majority needed for adoption as follows:

President offered congratulations to all the winners.

### **Item 9 Committee Elections.**

The Returning Officer declared all positions vacant.
